#### **GENERAL CONDITIONS OF USE**

## Introduction

This document contains the general conditions of use of the website at http://www.in-lombardia.it owned and operated for all operational purposes by ARIA S.p.A., with registered office in Milan (Italy), Via Torquato Taramelli, 26, VAT no. 05017630152 (hereinafter referred to respectively as "Terms and Conditions" and "Website") with which all persons intending to navigate on the pages of the Website (hereinafter referred to as "User" o "Users") must comply.

Connection, access to the Website and, in any event, any action involving navigation on its web pages imply full and unconditional acceptance by the User of all the provisions of these Conditions.

These General Terms and Conditions may be changed at any time, upon the occurrence of a justifiable reason. In particular, they may be amended not only in terms of mere formal changes and to introduce more favourable conditions than those set out herein, but also upon the occurrence of the following events/requirements: (i) in the event of technical requirements; (ii) in the event of changes to the relevant laws and regulations; (iii) in the event of changes to the use of the services. In cases where the General Terms and Conditions are amended - except for purely formal changes, changes that improve the user's experience, and for the introduction of a new service - the user will be notified by means of appropriate notices through the Website. These changes will be effective as of the date to be indicated in the notice.

# **Article 1 - Industrial and Intellectual Property Rights**

#### **Article 3 - Personal Data**

Any personal information and, in general, any other data of a confidential nature that may be provided by the User shall be processed for the purposes and in the manner better described in the Privacy Policy containing provision on personal data processing, published on the website www.in-lombardia.it in the section PRIVACY AND COOKIES.

## **Article 4 - Cookies**

A cookie is a small text sent by the Website to the User's browser, which is stored on the User's personal computer or other device.

The cookie is used to record data relating to the User's navigation on the Website for the purpose of providing personalised information so that the server of the Website operator can identify the User.

### Article 5 - Links and hyperlinks to other websites
